It reviewed the documents submitted by the manufacturer, performed the initial type test on the sample, performed the initial inspection of the factory, assessed the factory production control system and found that the aforementioned product fulfils the requirements of the construction technical certificate 227-STO-17-0107 which relate to the essential requirements.

The authorized body found that the factory production control system is in accordance with the respective technical documentation and ensures that products placed on the market fulfil the requirements of the aforementioned construction technical certificate and are in compliance with the technical documentation according to § 4 paragraph 3.

An integral part of this certificate is Protocol No. 227-P5-17-0107 of 27.03.2017 which contains the conclusions of the assessment, verification, test results and a basic description or illustration of the certified product necessary for its identification.

The Authorized Body no. 227 performs at least once in 12 months surveillance of due functioning of the factory production control system, takes samples in the factory, performs testing on them and assesses, whether the product properties are in accordance with the construction technical certificate according to § 5, clause, 4 of the aforementioned government regulation. In case the authorized body identifies deficiencies it is entitled to cancel or change this certificate.
